WHEREAS RIVER OAK ARABIAN STUD is the owner of the stallion

is the owner/lessee of the mare named

Reg. No. Colour AND WHEREAS the

stallion..... will stand at stud during

the 2..... breeding season at River Oak Arabian Stud, Wilberforce NSW and the parties hereto desire to contract for services of the stallion for one season's booking.

IT IS AGREED as follows:

1. BREEDING FEE

The breeding fee shall be \$1,100.00/\$660.00. Of said amount, a non-refundable Mare Booking or Nomination Fee of \$220.00 shall be due upon execution of this contract and the remaining \$880.00/\$440.00 shall be payable on a forty-five (45) day positive pregnancy test.

2. ADMINISTRATION FEE

Administration Fee of \$33.00 dollars is payable with Booking Fee to River Oak Arabian Stud for all mares requiring Transported Semen.

3. VETERINARY ACCOUNTS/COURIER CHARGES

All veterinary and courier costs related to the collection and transportation of chilled semen are charged directly to the mare owner/lessee and are **PAYABLE IN ADVANCE**

by the mare owner(s) or representative to our Veterinary Clinic doing the collection and are the sole responsibility of the mare owner/lessee. *Please remember to organize this when requesting semen from River Oak.*

4. PHOTOCOPY

A photocopy of both sides of the mare's registration certificate (where applicable) must accompany this Breeding Contract.

5. RETURN BREEDING PRIVILEGES

None of the abovementioned fees shall be refundable. River Oak Arabian Stud guarantees a return breeding in the following season, either for said mare or *an approved* substitute (if the original mare, for which a Service Fee was paid, dies) should a live foal (defined as one that stands and nurses without assistance) not result from this mating, or foal dies before reaching 24 hours of age. This is to be evidenced by a written statement from a qualified veterinarian within one (1) week from death of foal. A mare owner/lessee who does not comply with herein-defined statement waives his season return rights and privileges and holds River Oak Arabian Stud harmless of all liabilities and responsibilities. Fees for a return breeding shall include a handling fee based on the new season's rates and all veterinary and courier fees for A.I. are the responsibility of the mare owner/lessee and will be charged at the prevailing rate at the time of collection of semen.

6. ENTIRE AGREEMENT

This agreement constitutes the entire agreement between the parties and may not be modified except in writing signed by both parties hereto. This contract shall not be assigned or transferred by either party hereto without the consent of the other. If the mare is to be re-bred and the mare owner/lessee fails to do so the following year, then any and all fees paid shall not be refundable and this contract is hereby cancelled.

7. GST

All prices are GST inclusive.
